Digital Specs

- Required File Format: PDF X1-A
- Offset all crop marks .125"
- Keep live matter 3/8" from trim on all sides
- Allow 3/16" safety at gutter of each page for type running across gutter -Perfect alignment of type across gutter of two facing pages cannot be guaranteed
- Follow SWOP for all materials
- Total density should not exceed SWOP, which is 300%
- Files should comply with SWOP standards between 200-400 dpi. Line Work at 2400 dpi
- Images for 4/C ads must be submitted as final high resolution CMYK files. Pantone and RGB colors will cause the file to be rejected and we will ask for a replacement file from you
- Please note- file should be printed to a postscript and then distill postscript file using Acrobat Distiller- Spec sheets available upon request
- Magazine jogs to the foot and is saddle stitched

Proof Specs

- Provide (1) SWOP-approved contract proof and (1) laser created from the file being submitted
- Contract proof may be Kodak Approval, CREO spectrum IRIS digital or Digital Waterproof
- Proof must meet all SWOP specifications and must include a 6mm 5%, 25%, 75% and 100% CMYK patch strip for quality color
- A label sheet specifying the type of proofing device should accompany each proof, along with the name and phone number of the contact person
